### TENNESSEE ALCOHOLIC BEVERAGE COMMISSION

## Minutes June 23, 2009 1:30 p.m.

The regular meeting of the Tennessee Alcoholic Beverage Commission was held on Tuesday, June 23, 2009 in Nashville, Tennessee at 1:30 p.m. Commissioner Cynthia Bond and Commissioner Harlan Mathews were present. Although Chairman John Jones was not present, a quorum was present and the meeting was held. Executive Director Danielle Elks, Assistant Director Carolyn Smith and CLEO Mark Hutchens were present.

1. The Minutes for May 21, 2009 Commission Meeting were approved.

## 2. RETAIL

A. TRE WINES & SPIRITS
NASHVILE, TENNESSEE (DAVIDSON COUNTY)

**Applicant:** Phoenix Entertainment, LLC

**Member:** Tracy Burris

Before the Commission is a request for a new retail store to be located at 2181 Nolensville Road, Suite 202 in Nashville, Tennessee. Mr. Burris intends to initially invest \$80,000 from personal savings and 401(k) investments to operate the business. If approved, Mr. Burris will operate the business as a LLC. Mr. Burris is leasing the property from Emeco Properties, LLC for a period of one year with rent ranging from \$500/month to \$2000/month. An option to renew the lease for a three year term exists with terms to be renegotiated. All documentation has been submitted with the exception of the following:
