### MINUTES Tuesday, July 26, 2016 1:30 pm

Chairperson McDaniel, Commissioner Jones, and Commissioner Kaegi were present. Clay Byrd, Executive Director, and Staff Attorney Joshua Stepp were in attendance. Assistant Director, Zack Blair arrived shortly after the meeting began. Chairperson McDaniel called the meeting to order at 1:35 p.m.

Before the Commission is a request for a complete transfer of ownership regarding the retail package store business located at 1318 Sparta Pike, Lebanon, TN 37090. Applicant intends to purchase the business from the current owners and would be leasing the premises from Cato Industrial Development, LLC, at a monthly rental rate of \$3,500. This sale is occurring in part due to settlement negotiations with Sparta Pike regarding sales to minors and failure to cooperate, in which Sparta Pike has agreed sell the store to an approved purchaser in lieu of further legal proceedings.

Rita Patel's husband, Sanjay Patel, is the former owner of Yogibapa Inc. d/b/a Castle Heights Wine & Spirits. In August, 2015, TABC staff initiated revocation proceedings against licensee Yogibapa Inc., for sales to minors made by Mr. Sanjay Patel in April of 2015, and December of 2014 and for a third sale by an employee in June, 2014. The business was sold to the current licensee at that location pursuant to an agreement with the TABC and the license of Yogibapa Inc. d/b/a Castle Heights Wine & Spirits was deemed revoked. In addition, in settlement of a criminal case against Mr. Sanjay Patel for multiple sales to minors, Mr. Sanjay Patel agreed to not have or apply for a license for 5 years or work at a licensee for 3 years.

TABC Rule 0100-03-.09(4)<sup>10</sup>, reads, in part: No wholesale or retail license will be issued to the spouse, child or children.....of a licensee whose license has been revoked, for the privilege of doing business at the same location or in close proximity to the location of the establishment whose license was revoked for a period of one (1) year after said revocation. In order to grant the license in question to Rita Patel, the wife of Sanjay Patel, the Commission must affirmatively

TABC Rule: 0100-03-.09(4): (a) No wholesale or retail license will be issued to the spouse, child or children, son-in-law, daughter-in-law or other person having any interest in the business of a licensee whose license has been revoked, for the privilege of doing business at the same location or in close proximity to the location of the establishment whose license was revoked for a period of one (1) year after said revocation. The Commission may, in its discretion, waive this prohibition. (b) The Commission may refuse to reissue a license to the same person, firm or corporation whose license has been revoked for one (1) year from the date of said revocation.

waive the prohibition of the above rule. <u>TABC staff recommends denial of the waiver of the</u> above rule and denial of this application based on the facts summarized above.

Discussion/Action Taken: Josh Stepp reviewed the matter to the Commission and Attorney Matt Scanlan addressed the Commission on behalf of Rita Patel. Mr. Scanlan noted that Ms. Patel was the sole owner of the establishment and is willing to provide affidavits of ownership stating that she will not allow her husband to work in the store for at least the period in the agreement with the DA and that if her husband is found to work in the store, she will surrender the TABC license. Mr. Scanlan also questioned staff's assertion that the surrender of the license was deemed to be a revocation lacking any documentation of a revocation.

Commissioner Jones commented that he was not comfortable denying the application lacking written documentation of the revocation of the license.

Director Byrd commented that in light of these statements we will make sure that any order is a codification of that disposition to the extent that it's clear about our ability to revoke under the circumstance.

Commissioner Kaegi, noting that time was needed to study the issue, motioned to continue the matter to the August meeting. Commissioner Jones seconded the motioned and it passed with three ayes.
