

TENNESSEE ALCOHOLIC BEVERAGE COMMISSION MINUTES TUESDAY, DECEMBER 18, 2018 10:00 a.m.

The meeting was held on December 18, 2018, in Nashville, Tennessee. Chairman Skiles, Commissioner Jones, and Commissioner Roberts were present. In attendance on behalf of staff were the following: Interim Director Blair, Commission Counsel Joshua Stepp, Commission Counsel Hollingshead Cook, CLEO Tubbs, Nancy Townsend, Scott Wolfe, and Nichelle Dorroh.

1. REVIEW/APPROVAL OF THE NOVEMBER 15, 2018, COMMISSION MEETING MINUTES

<u>Discussion/Action Taken</u>: Commissioner Jones moved the minutes be accepted as presented and the motion was seconded. The motion passed with three ayes.

Presentation by Michelle Rozell of Mothers Against Drunk Driving (MADD). Michelle Rozell presented the 2018 Statewide Outstanding Department of the Year Award to the Tennessee Alcoholic Beverage Commission, law enforcement division. Ms. Rozell commended the department on its effort to prevent underage drinking.

Before the Commission is a request for approval of a change in ownership in O.T. Investments Inc., the retail package store licensee doing business at 330 Franklin Rd., Brentwood, TN 37027. Tennessee Fine Wines & Spirits, LLC will become the 100% owner of O.T. Investments Inc. The TABC staff recommends approval of the request.

Discussion/Action Taken: Director Blair summarized the request and recommended approval of the request. Kurt Winstead requested to address the commission and requested the commission deny the application or delay a decision until the case before the Supreme Court is over.

Mr. Winstead made comments regarding on an ongoing investigation, minor beneficiaries of the trusts, and the pending Supreme Court case. Mr. Winstead commented on and inquired about the length of the investigation. Director Blair addressed the commission regarding the investigation process. A discussion was held regarding the investigation process.

Commissioner Roberts asked for assurances that the investigation is proceeding in a timely manner. Director Blair responded and commented that he requests regular updates on these types of investigations.

Director Blair then commented on the appeal against the commission involving the minor beneficiary issue that was non-suited. A discussion was held. Commission Counsel Stepp spoke on the agency's position regarding trusts with minors as beneficiaries and Mr. Stepp commented on the use of trusts for legitimate estate planning purposes.

Director Blair commented on the injunction and read from the order. Director Blair commented that he believed the commission was prohibited from considering the pending case as a basis to delay the application.

Tucker Herndon addressed the commission on behalf of Tennessee Fine Wine and Spirits and commented that the applicant has met the requirements for the transfer of the license. In response to a question from the commission regarding tastings, Robert Schaffer addressed the commission and spoke on Total Wine's practice related to tastings and educational classes.

Kurt Winstead addressed the commission again and made comments and responded to a question from the commission regarding classes. Mr. Winstead made additional comments. Robert Schaffer then addressed the commission in response to Mr. Winsted's comments.

The commission held a discussion and included were comments that the concerns raised do not rise to the level of delaying or denying the application. After the discussion, Commissioner Jones moved application be approved and the motion was seconded. The motion was approved with three ayes.

Discussion/Action Taken: Director Blair summarized the request and commented on the background of the application. Director Blair noted a change to the recommendation by staff. Attorney Thomas Branch was present on behalf of the applicant. Director Blair noted the applicant had waived confidentially regarding the child support issue. Director Blair noted that Mr. Tate was now in compliance with his child support obligation and noted the identity question is now resolved. Director Blair recommended conditional approval subject to the receipt of the 2018 license fee, an agreed order that specifies that the licensee with surrender the license automatically if the licensee comes out of compliance with the child support payment plan or other terms of the agreed order, an inspection which includes an acknowledgment of rules and regulations, and the license fee for the current application. Director Blair noted as part of the agreed order that staff will request documentation showing compliance with the child support plan on a regular basis and staff will also request updated from DHS at renewal. Director Blair stated that staff is requesting a deadline be set for January 2, 2019 for the contingent items. Director Blair noted Mr. Branch reviewed a draft of the agreed order and was in agreement with the terms. Commissioner Roberts inquired about the driver's license issue and Special Agent Andrew Farley spoke on this issue and a discussion was held.

Mr. Branch commented that he read the draft of the agreed and it was satisfactory and a brief discussion was held.

Commissioner Roberts moved for conditional approval subject to the agreed order as discussed by Director Blair and all the material terms must be present in the agreed order. Commissioner Roberts requested Director Blair to repeat the other contingent items. Director Blair then listed the items: payment of the 2018 license fee, inspection which includes an acknowledgment of rules and



regulations, and a license fee for the new license on or before January 2, 2019. The monthly compliance updates and renewal updates will be in the agreed order and payment of the initial payment required by the court be honored by January 2, 2019, will be a part of the agreed order. Director Blair noted that as part of the agreed order the license will be surrendered voluntarily without a hearing if the terms are violated. Commissioner Roberts moved for approval subject to those conditions and the motion was seconded. The motion passed with three ayes.

All trucks and other motor vehicles owned or leased and operated by any Tennessee licenseed wholesaler, and used to transport, haul, deliver, or carry alcoholic beverages, shall have the name and address of such licensee printed on each side and on the rear of said truck or motor vehicle in legible letters of a minimum height as hereinafter prescribed. The name of the licensee shall be in letters not less than four (4) inches in height, the address of such licensee shall appear in letters of not less than two and one half (2 ½) inches in height and the license rumber shall appear in letters not less than and one half (1 ½) inches in height. The following words, but no others, may be abbreviated: Tennessee (Tenn.), Company (Co.), and Incorporated (Inc.).

<u>Discussion/Action Taken</u>: Director Blair summarized the proposed rule change and requested the commission approve the proposed rule change that would eliminate the language requiring wholesalers to paint or print their license numbers on their vehicles. Director Blair commented that it would be a burdensome requirement to require wholesalers to repaint their vehicles with the new license numbers. Attorney Hank Hildebrand was present on behalf of



the Wine & Spirits Wholesalers of Tennessee stated the association was in support of the proposed change. Commissioner Roberts moved approval of the proposed rule and the motion was seconded. The motion passed with three ayes.

RLPS update

<u>Discussion/Action Taken</u>: Director Blair updated the commission on RLPS and the licenses issued. Director Blair commented on changes to the inspection process in the system that will now allow for proactive renewal inspections by automatically generating inspection records on the license record for renewals.
