1:06 p.m. Welcome and DoHR Introductions

Commissioner Carter welcomed the group and initiated the roll call. DoHR facilitators Jennifer Harris Brown and Carlos Holmes introduced themselves to the Task Force.

1:11 p.m. DoHR Facilitated Discussion

Jennifer and Carlos asked the group to explain what they wanted to walk away from the day's meeting with:

- Phil Acord: A sense of what the possibilities are and what we can do to make Tennessee the best state in the nation around early childhood development
- Senator Massey: Actionable steps to increase access to childcare and solutions that are user-friendly and consumer-driven
- Jamie Stitt: Elimination of childcare as a reason that some are unable to enter the workforce and collaboration between daycares and companies
- Chloe Moore: Process mapping

Pat Sheehy noted that the objective shouldn't be actionable steps yet but starting at the beginning and adding shape and structure to the problem definition, as well as an inventory of challenges for the future consultant to tackle. Assistant Commissioner Jude White agreed and added that solutions should be built for the future state, not the current state.

Jennifer noted that DoHR has a team that handles process mapping that could help with that process.
