Dear Mr. Smolnycki,

The Department of Human Services (DHS) – Division of Audit Services staff conducted an unannounced on-site monitoring review of the Summer Food Services Program (SFSP) at Boys and Girls Clubs of the Smoky Mountains (Sponsor), Application Agreement 00-008, on August 15, 2019. Additional information was requested and provided on August 19, 2019. The purpose of this review was to determine if the Sponsor complied with the *Title 7 of the Code of Federal Regulations* (CFR) applicable parts, provider agreement, and applicable Federal and State regulations.

Based on our review of the Sponsor's records and information provided, the Sponsor had 11 feeding sites operating during the review period. The **King Family Library** and **Boys & Girls Club of Seymour** sits were selected as sample sites. In addition, we reviewed all meal counts for all sites operating during the review period.

#### Background

SFSP Sponsors utilize meal count sheets to record the number of breakfast, lunch, supper, and supplement meals served. Meals served by participating Sponsors must meet the minimum guidelines set by the United States Department of Agriculture (USDA) and DHS to be eligible for reimbursement. The SFSP Sponsor reports the number of meals served through the DHS Tennessee Information Payment System (TIPS) for reimbursement.

We inspected meal count sheets for our test period and reconciled the meals claimed to the meals reported as served for each meal service. We also assessed compliance with civil rights requirements. In addition, we observed meal services on July 9, 2019 at the sample sites.

Our review of the Sponsor's records for July 2019 revealed no significant deficiencies.

#### **Technical Assistance Provided**

During our monitoring visit on August 15, 2019, the Sponsor neither requested nor was provided technical assistance.
